## **Report to ENVIRONMENT & POLICY Committee for decision**

### **SUMMARY**

The purpose of this report is to adopt a report on Council's Dog Control Policy and Practices for the full year - 1 July 2009 to 30 June 2010 as required by section 10A of the Dog Control Act 1996 (DCA).

This section requires Council to report on a number of aspects of its administration of its dog control policy responsibilities.

### **RECOMMENDATIONS**

## 1. BACKGROUND

Section 10A of the Dog Control Act 1996 requires territorial authorities to publicly report each financial year on:

- the administration of their dog control policy and their dog control practices (Section 10A(1)); and
- a variety of dog control related statistics (Section 10A(2)).

While not explicitly stated in the Dog Control Act, one of the primary purposes for preparing this report is to allow communities to see how Council is managing its dog control responsibilities.

## 2. DISCUSSION AND OPTIONS

### Current Situation – Dog Control in City/District

Council is responsible for the enforcement of regulations relating to the keeping, welfare and control of dogs within the Gisborne District Council. Council is required under the Dog Control Act to make provision for the control of dogs and the damage they can cause.

Impounding of dogs is an activity required by the provisions of the Dog Control Act and associated Gisborne District Council Dog Control Bylaws and Dog Control Policy.

The Council has a responsibility to respond to complaints relating to dogs. Council's long term focus for dog control activities is to ensure a safe living environment is maintained through the monitoring and enforcement of legislation, regulations and bylaws.

Council adopted its "Dog Control Policy" in 2004. The policy provides a practical framework for the care and control of dogs throughout the district while minimising any danger, distress and nuisance to the community generally.

The policy outlines expected standards and behaviours from dog owners and provides information about how Council will administer dog control.

Dog practices and specific dog control functions include:

- dog registration
- impounding
- 24-hour ranging service
- targeted education
- enforcement of the Act and Council Dog Control Bylaw
- prosecutions

Council's Dog Control Bylaw is under review because of an unintentional inclusion in the bylaw (reviewed in 2007) of a district-wide inclusion of dogs permitted to be kept in a rural area without a licence. Council's Dog Control Policy will also be reviewed as part of this process. Submissions will be received up to 24 October 2010 then will go to a hearings meeting possibly in December.

Council has three full-time Gisborne based animal control officers, plus one part-time officer. The Council's Te Puia Springs office has two full-time animal control officers and two part-time stock rangers. The work of the latter officers are funded by Transit New Zealand. The animal control officers are responsible for covering a land area of 8,360 square kilometres and 3,360 kilometres of public roads, and 330 kilometres of State Highway.

All residential properties, urban and rural, are visited (door-to-door) and checked annually to find new unregistered dogs and any dog/owner changes. Due to kennel cough outbreak, acting on veterinary advice, only 45% of properties were visited. The rest were by phone contact.

All properties within the Gisborne city with more than one dog require an application for multiple dog licence. The licence is issued on meeting the dog control policy's criteria. Extra care is taken to ensure the dogs' welfare needs are met and that there are no noise problems for neighbours.

Animal Control Officers visit and check the properties of special owner applicants. These owners are entitled to a special discount to the registration fee and must be completed and applied for prior to 1 June annually.

Animal Control Officers test special owners who have applied to become New Zealand licenced owners who are entitled to further discounts. Concessions are made for specific categories of dogs.

The 5,800 dog owners within the district own 11,877 dogs, in the following categories:

Voluntary Hydatids activities resulted in dog owners purchasing 11,376 hydatids pills over the 12-month period.

With the introduction of the National Dog Database, all dog registrations and information is automatically transferred to the database on a nightly basis using a defined electronic format.

Extra work has been created with the breed definition of dogs on what the database will accept - must be a predominate breed.

#### **Council's relationship with key stakeholders in the community**

- Gisborne District Council (GDC) animal control pay rental for Gisborne Dog Training Club
- GDC contribute to Poverty Bay Charity Sheepdog Trials
- GDC contribute to SPCA for accepting and rehoming dogs under three months of age. Dogs that cannot be rehomed are evaluated on temperament.

- Due to the SPCA changing to a 'no kill policy' during 2009/10 year, animal control have had the extra burden of housing and feeding and mostly destroying pups under three months of age. Noise problems (barking) at the SPCA has also been a factor. Any noisy dogs (welfare cases) come to the Pound in an attempt to satisfy the nearby neighbours.
- All veterinarians have a close working relationship with the animal control section concerning microchipping records, nurturing of menacing and dangerous dogs plus up-to-date information regarding dog health problems.

### 3. DOG CONTROL ENFORCEMENT PRACTICES AND STATISTICS

(a) There were 890 dogs impounded. Details are:

- claimed - 294
- destroyed - 439
- returned - 108
- rehomed - 38
- to SPCA - 11
- still held - 6

(b) All properties with known dogs throughout the Gisborne District are visited and personally viewed by staff. Any dogs that are wholly or predominantly any of the four restricted menacing breeds, specified in the Dog Control Act 2006, are classified as menacing under type or nature. Compliance must be met by muzzling in public, neutering and control.

The restricted breeds are:

- American Pit Bull Terriers
- Dogo Argentino
- Brazilian Fila
- Japanese Tosa

Microchipping of these dogs plus dangerous dogs has been progressive. Microchipping of all dogs first registered from 1 July 2006 (except working farm dogs) has been carried out - number chipped to date - 2,832 dogs.

#### Education

- Presentations were carried out in nineteen schools (17 on the coast, two in Gisborne), meter readings, Gisborne cubs, combined rural schools (7) at Ngatapa.
- Dog owners are given an Animal Control Information Bulletin as dogs are microchipped.
- An animal control officer is always available on request for speaking engagements and presentations.

## **Dogs Prohibited, Leash Only and Dog Exercise Areas**

Council has made provision for areas where dogs are prohibited, permitted on leashes or allowed freedom for exercise purposes. These areas are regularly patrolled.

- Dogs roaming after-hours are controlled by dog trapping
- Defecating dogs are in the minority. It is a hard area to police or prove who the offender is or was unless caught in the act.
- Dealing with impounded dogs with the long wet winter; the pound is hard to keep dry. At the time of writing there were 82 dogs in the pound.

## **6. LEGAL**

### **Dog Control Act 1996**

[10A Territorial authority must report on dog control policy and practices

- (1) a territorial authority must, in respect of each financial year, report on the administration of-
  - (a) its dog control policy adopted under section 10; and
  - (b) its dog control practices.
- (2) The report must include, in respect of each financial year, information relating to-
  - (a) the number of registered dogs in the territorial authority district;
  - (b) the number of probationary owners and disqualified owners in the territorial authority district;
  - (c) the number of dogs in the territorial authority district classified as dangerous under section 31 and the relevant provision under which the classification is made;
  - (d) the number of dogs in the territorial authority district classified as menacing under section 33A or section 33c and the relevant provision under which the classification is made;

- (e) the number of infringement notices issued by the territorial authority;
  - (f) the number of dog related complaints received by the territorial authority in the previous year and the nature of those complaints;
  - (g) the number of prosecutions taken by the territorial authority under this Act.
- (3) The territorial authority must give public notice of the report:
- (a) by means of a notice published in:
    - (i) one or more daily newspapers circulating in the territorial authority district; or
    - (ii) one or more other newspapers that have at least an equivalent circulation in that district to the daily newspapers circulating in that district; and
  - (b) by any means that the territorial authority thinks desirable in the circumstances.
- (4) The territorial authority must also, within one month after adopting the report, send a copy of it to the Secretary for Local Government.
