Fees and Charges

This section highlights any significant changes to Council's fees and charges.

Trade Waste Fee

It is proposed to increase the trade waste discharge fee from its current rate of 1.1¢ per cubic metre of wastewater discharged to 30¢ per cubic metre effective from 1 July 2009. This fee is paid by industries whose trade waste flows through the city wastewater system.

A rate of 30¢ per cubic metre better reflects the estimated industry share of the annual wastewater system operating costs. This rate is also in line with the estimated industry share of the operating costs expected when the new wastewater treatment plant is commissioned in December 2010.

The proposed fee will place Gisborne District Council in the mid-range of fees charged by other councils investigated.

Assuming the same volume discharge, the difference in revenue to Council is an annual increase of \$351,325.16.

Solid Waste

It is proposed to introduce a surcharge of \$10 per tonne on all waste through transfer stations. This is to recover past deficits resulting from the investigation for a district landfill. This will be collected on behalf of Council by our waste contractor.

Water Connection Fee

It is proposed to increase the water connection fee by 3% on 2008-09 prices from \$350 to \$360 inclusive of GST.

Environment and Planning

In most cases it is proposed to increase fees and charges by 3% on 2008-09 prices. A notable exception is the proposed increase to the infringement fee for parking illegally in a disabled carpark. It is proposed to increase this from \$40 to \$150, an increase of 275%. Other exceptions are where prices have been increased to reflect the actual and reasonable cost of providing the service.

Deposit fees for land-use and subdivision resource consents have been introduced in line with common national practice. Some subdivision processing fees have been increased to reflect staff time input and to better align with national practices. A discount for prompt payment of dog registration fees (rather than penalties for late payment) has been introduced.

Cemeteries

It is proposed to increase all cemetery fees and charges by 3% plus a rounding up/down effect. These were last increased in 2004.

Waikanae Holiday Park

It is proposed to increase charges for all accommodation types by 8% on 2008-09 prices. The 8% consists of about 3% inflation and 5% growth, in line with market movements.

Vehicle Testing Station

There is no change proposed for retail prices for cars and light commercial or trailer and caravans but discounts applied to bulk and trade have been reduced from 2008-09 prices.

HB Williams Memorial Library

It is proposed to decrease scanning and printing from \$1 to 20 cents. No other changes are proposed.

Community Housing

On average, Council currently charges rents at 35% below the market rate for its community housing. These rents do not cover operating costs.

It is proposed to increase rents to 10% below market rates incrementally over the next few years.

Council also intends to reduce operating costs to comply with its Revenue and Financing Policy which stipulates 100% user pays.

Theatres

The table below lists the proposed increases to hireage fees and miscellaneous charges for theatres. There has been no change to fees and charges since at least 2006.
