#### State what parts of the application you support or oppose or wish to have amended:

The upgrade of the infrastructure to increase import capacity, holding capacity and the means to berth two vessels safety in the harbour.

There is much potential to export all other products form our region especially rural communities on the East Coast north of Gisborne. Importing goods/products to the Gisborne Port provides more freight option for Te Tairawhiti and the East Coast region right up to Lottin Point, East Cape as there are Manuka Honey Factories, forestry etc.

Less traffic on the highway dispatching produce and products region to region. Faster turn around for truck drivers who have a limited time on the road or no stand down periods for truck drivers as port reaches it capacity. A consistent flow of logs over the wharf meaning forestry crews (our Coast whanau) aren't being laid off or must stop for weeks or even months.

Upgrade of assets and infrastructure so:

Two or more vessels can berth in the harbour at the same time – Increasing export trade, accommodating the regions forecast log volumes, produce volumes and much more.

Employment opportunities in both the upgrade of the port (contractors) and the productivity line.

40% of the traffic volume on State Highway 35 is Heavy Vehicles moving logs, products nationwide. Transportation via vessel is considered much safer and productive as products will move from one port to another. Gives roading contractors ample time to do major emergency works on subsidence sites and dropouts with less disruption.

Blackbee Contractors are a Tier 3 roading construction team of skilled contractor with much experience and expertise. My team have completed alignment works on the port previously, this opportunity also gives my local people employment to work alongside other contractors doing the infrastructure works needed.

Stage 2: The extension of Wharf 8, rebuilding of the outer breakwater, building a reclamation & upgrading of the Southern Log yard.
