

Privacy statement

The information provided on this form will be used to ensure burials occur in the correct plots and that accurate records are maintained for the future. Staff have direct access to this information. In appropriate circumstances, this information may be shared with those seeking detail/locations of deceased relatives and their descendants. The information requested is required under the Burial and Cremation Act 1964 and associated Council bylaws. Under the Privacy Act 2020, you have the right of access to personal information about you held by the Gisborne District Council and you are entitled to request information about you to be corrected.

Approved repayment plans

I agree I am indebted to Gisborne District Council for the costs of a burial plot (the Sum) and that I will pay this sum in accordance with the following terms:

- I will pay the Sum in equal monthly instalments over a period of 6 months the first instalment to be paid within 28 days of the date of this agreement and thereafter within 28 days of the last payment continuing until the Sum is paid in full
- Should 2 payments not be paid on time Gisborne District Council may cancel this agreement without notice and this agreement will come to an end and you will no longer have any interest in the burial plot.
- · Any outstanding debt will incur interest at 2% per month, charged daily.
- · Legal, administration and collection costs incurred in collecting any overdue debt will be charged onto you.
- If Council is required to undertake action for recovery of outstanding debts or dishonoured payments you will be charged the direct
 costs and disbursements incurred by Council (including on a solicitor client basis) or any such enforcement.

While Gisborne District Council will make reasonable endeavours to provide a particular plot, it will only warrant that a plot will be provided for burial. It is not responsible for any errors or omissions, in providing a particular plot with no guarantee of completeness, accuracy, or timeliness, and without warranty of any kind, express or implied.

To the fullest extent permitted by law, the total liability, in the aggregate of Gisborne District Council, its contributors, directors, officers, employees, to you and anyone claiming by, through, or under you for any claims, losses, costs, or damages whatsoever arising out of, resulting from or in any way related to the purchase of a burial plot or this Agreement from any cause or causes, including but not limited to negligence, professional errors and omissions, strict liability, breach of contract, or breach of warranty, shall not exceed the cost of your burial plot.

This disclaimer of liability applies to any damages or injury, whether based on alleged breach of contract, tortious behavior, negligence or any other cause of action, including but not limited to damages or injuries caused by any failure of performance, error, omission, interruption, deletion, defect, delay in operation or transmission, computer virus, communication line failure, and/or theft, destruction or unauthorized access to, alteration of, or use of any record.
