## Privacy Statement

The information provided on this form will be used to ensure burials occur in the correct plots and that accurate records are maintained for the future. Staff have direct access to this information. In appropriate circumstances, this information may be shared with those seeking detail/locations of deceased relatives and their descendants. The information requested is required under the Burial and Cremation Act 1964 and associated Council bylaws. Under the Privacy Act 1993, you have the right of access to personal information about you held by the Gisborne District Council and you are entitled to request information about you to be corrected.

## Approved Repayment Plans

I agree I am indebted to Gisborne District Council for the costs of a burial plot (the Sum) and that I will pay this sum in accordance with the following terms:

- I will pay the Sum in equal monthly instalments over a period of 6 months the first instalment to be paid within 28 days of the date of this agreement and thereafter within 28 days of the last payment continuing until the Sum is paid in full
- Should 2 payments not be paid on time Gisborne District Council may cancel this agreement without notice and this agreement will come to an end and you will no longer have any interest in the burial plot.
- Any outstanding debt will incur interest at 2% per month, charged daily.
- Legal, administration and collection costs incurred in collecting any overdue debt will be charged onto you.
- If Council is required to undertake action for recovery of outstanding debts or dishonoured payments you will be charged the direct costs and disbursements incurred by Council (including on a solicitor client basis) or any such enforcement.
