Subject: Te Kura Kaupapa Māori O Horouta Wānanga in Kaiti

Kia Ora Teina,

Thank you for your discussion on Tuesday.

As discussed, the Ministry of Education (Ministry) is working with Te Kura Kaupapa Māori O Horouta Wānanga (TKKM O Horouta Wānanga) to relocate the kura to a new, larger site.

TKKM O Horouta Wānanga signalled a strong desire to relocate their kura near Te Poho o Rawiri Marae in Kāiti in Gisborne. The Ministry has acquired several properties in the vicinity of the marae and wishes to designate the following properties (see map attached):

- 5, 7, 9, 17, 23, 25 and 27 Ranfurly Street;
- 161 and 165 Crawford Road; and
- a portion of Barton Street

As discussed, the Ministry will apply to the Gisborne District Council to have these properties designated for "Education purposes". This is the first step in a two-step process. Detailed design and master planning for the kura (including new buildings, parking area, playgrounds, sportsfields etc) will occur after the designation is confirmed.

The Ministry will seek that Council publicly notify the application and invite formal submissions. However, the Ministry wish to engage with Rongowhakaata prior to lodging this application with Council to seek feedback.
